## Minutes of the meeting held at the Council Offices on Wednesday 15<sup>th</sup> July 2020

Due to the Covid19 pandemic and related restrictions the meeting was held remotely using the Zoom Cloud meetings application

**Present:** Councillor Bromilow (Town Mayor); Branyan; Gardner; Grisenthwaite;

**In attendance**: Bob Bailey, Parish Clerk; City Councillor Guilding

20057 Apologies: Apologies were received from City Councillor Yates and County Councillor

Williamson

**Declaration on interests and dispensations:** Councillors Gardner, Grisenthwaite and Watkins were granted a dispensation to comment on planning application 20/00607 and a specific matter in the Finance & Governance Minutes. Councillor Jones was granted a dispensation to comment on any matters relating to the Salvation Army and/or Carnforth

Carnival Committee.

**20059 Urgent Business**: Members raised urgent business on the following matters:

1) Weeds management & grass cutting: There was a discussion on the state of the weeds and need for grounds maintenance in Carnforth and surrounding areas. It was noted that Lancashire County and Lancaster City Council staff resources had been deployed throughout the coronavirus pandemic to date and that this had had an impact. The Town Clerk also advised that Lancaster City Council had recently taken a decision to stop weed killing due to concerns about the potential effects if glyphosate (weed killer) and had handed back responsibility for weeding to Lancashire County Council.

Members acknowledged that the Carnforth community takes pride in the town and would support an initiative to deal with weeds locally – a Clean-up day to remove litter and weeds has been jointly planned between Carnforth Rotary Club and the Town Council and residents and businesses will be encouraged to get involved going forward. Suggestions for controlling wildflowers on verges will also be considered. **ACTION:** Issues to be considered and managed further by Committees as appropriate.

- 2) Carnforth Community Swimming Pool: A request has been made that the Town Council considers an unspecified financial provision to support the cash flow position following its closure during the coronavirus pandemic and as it prepares to re-open and plans to achieve its longer-term objectives. There a discussion around the circumstances and legality to provide a 'loan' and the need for more information on the current circumstances before a decision could be reasonably made. ACTION: Request that the Chairman of Carnforth Community Swimming Pools provides further details and supporting information
- 3) **Crag Bank Village Hall**: Councillors Grisenthwaite and Watson provided an update on the latest position regarding the stewardship of Crag Bank Village Hall and a useful meeting about the current legal position on the property and constitution. Further detailed consideration is required as well as a feasibility study around the fabric of the building and its short, medium and long-term future. **ACTION**: To be considered further by Committees as appropriate.
- 4) **Carnforth Express**: Members were advised that the August edition of the *Carnforth Express* will be 12 pages long given the amount of content. This edition will provide information on supporting local businesses as they start to open their doors to the public again and the outstanding work and support of our care community. There is also details about the plans of the *Friends of Crag Bank Play Area Group* who, with the support of Town and City Councils, are developing ambitious plans to improve Crag Bank Play Area and the surrounding grounds.

- There is also an article on the recent adoption of the Local Plan and comments about the impact of this on Carnforth and the surrounding area.
- 5) **Town Clerk's Terms and Conditions:** The Town Mayor and Councillor Grisenthwaite requested that the press and public be asked to leave at the end of the meeting so that the Town Council could consider the Town Clerk's current Terms and Conditions.
- **Minutes:** After some comments it was **RESOLVED** that the Minutes of the meeting held on Wednesday June 22<sup>nd</sup> 2020 be approved.

#### **20061** Adjournment for public discussion and information only updates:

1) Public Discussion: A representative from Aggregate Industries UK Ltd had been invited to speak about the Lancaster District Local Plan and specifically the objection around the long-term safeguarding of minerals. This resulted in significant modifications to the original Local Plan by the national Planning Inspectorate, including the removal of land that had been earmarked for affordable housing, a primary school, a sports hub and a new home for Carnforth Rangers Football Club.

The reasons for the legal challenge and the stated importance of safeguarding minerals were explained and the industries position challenged by Councillors, albeit in the knowledge that the Planning Inspectorate's decision is final and cannot be challenged until such time as the Local Plan comes under review in a few years' time.

Questions were also asked whether the industry would be willing to 'give something back to the town' in light of the facilities that had now been removed, whereupon, it was commented that 'significant contributions' had been made to the local community in the past and the potential for access to other funds, if available, will be advised.

The Aggregate Industries UK Ltd representative was thanked for taking the time to attend the meeting.

- 2) Action Plan: The Clerk reported that since all actions raised during the coronavirus pandemic had been dealt with, he will recommence providing further updates on 'business as usual' matters for Members information and consideration,
- 3) **Correspondence:** The Town Clerk presented the schedule of correspondence received and previously circulated to Councillors. It was reported that appropriate action had or will be taken by the Town Clerk / Councillors / Committees to address matters arising from the correspondence received.
- 4) Member updates / matters: Members commented on matters including:
  - a) Town Mayor: The Town Mayor reported on her activities in the last month acting on behalf of the Town Council, including arrangements for the planned Clean Up day and dealing with several matters raised by the local community;
  - b) **Covid-19 (Coronavirus):** The Clerk and Councillors reported on the latest updates and activities locally, particularly as local shops begin to re-open: Councillor Jones reported on early plans to develop a constituted and managed local volunteer group aimed at taking advantage of the great success of the Carnforth and Surrounding Areas Covid19 support group and expanding on this to many other areas of life in the local community;
  - c) Eden North Project: Councillors were informed about a very useful meeting with an officer from Lancaster City Council Regeneration and Planning Services about the developing plans around the Eden Project and the proposals for Carnforth's involvement. As a result of this meeting the Town Council's proposal will be redrafted and considered further as the plans go forward;
  - d) **General matters and issues:** There were no other matters to report in addition to items on the Agenda for this meeting.

- 5) Reports of Ward Councillors: City Councillors Guilding and Reynolds congratulated the Town Council and the local community of their many, and continued, achievements. They also provided relevant updates on a range of functions and activities of Lancaster City Council and matters of interest such as:
  - a) Adoption of the Local Plan and the implications for Carnforth and the surrounding area;
  - b) Business Support Scheme;
  - c) Residents issues and some public disorder as lockdown starts to ease;
  - d) Ongoing development of the 2030 plan and community engagement relating to these plans

#### 6) Reports from outside bodies:

- a) Carnforth Business Network Nothing to report;
- b) Carnforth & District Twinning Association Nothing to report
- c) Quarry Liaison Nothing to report
- d) Carnforth Neighbourhood Plan Working Group The Town Clerk provided a brief update on the progress of the Carnforth Neighbourhood Plan
- e) Carnforth Carnival Committee Meeting on 1<sup>st</sup> September 2020 at 7pm It was then **RESOLVED** that matters, reports and updates for information only be noted.

**20062** Annual Governance & Accountability Return (AGAR) 2019/20: The Town Clerk presented for approval the Annual Governance and Accountability Return and supporting papers; Internal Audit Report and the dates for the exercise of public rights of inspection.

Councillors were asked to note that the Internal Auditor, acting independently and based on an assessment of risk, carried out a selective assessment of compliance with relevant procedures and controls during the financial year ended 31<sup>st</sup> Match 2020. Based on the findings in the areas examined the internal audit conclusions were that, in **all significant** respects, the control objectives – as set out on the AGAR – had been achieved throughout the year to a standard necessary to meet the needs of the Town Council.

Councillors attention was drawn to Sections 1 & 2 of the AGAR setting out the 2019/20 Annual Governance Statement (Section 1) and the Accounting Statement (Section 2).

Councillors were reminded that is the responsibility of the Council to ensure that there is a sound system of internal control, including arrangements for the preparation of the Accounting Statements and supporting papers.

Councillors were also asked to note that under recently issued regulations (The Accounts & Audit (Coronavirus) Regulations) deadlines for submission of the AGAR and supporting papers to the Government appointed external auditors and their approval and publication had been extended to 31<sup>st</sup> August 2020, including a statutory 30 working days for the public right of inspection of the accounts. Subject to the Town Council's approval the Town Clerk recommended that the 30 day period commences on 20<sup>th</sup> July and ends on 29<sup>th</sup> August 2020.

Councillors thanked the Town Clerk for presenting the accounts and supporting documents and asked several questions before it was **RESOLVED** that

- 1) The Town Council notes the findings and conclusion of the Internal Audit Report;
- 2) That the Town Council approves the Annual Governance Statement 2019/20 (Section 1) and the 2019/20 Accounting Statements and that the AGAR be signed by the Town Mayor, and;
- 3) The period for the public rights of inspection be approved and details of this, together with the AGAR and supporting papers be published on the Town Council's website

**Planning applications & statutory consultations:** Councillors considered the following planning applications and road traffic orders:

Councillors were advised that both planning applications had been discussed by the Town Development and Planning Committee. It was noted that planning application 20/00596/FUL had been recommended for 'support in principle' and that there had been much discussion about 20/00607/VCN.

It was acknowledged that the Town Council had supported planning application 20/00607/VCN in the development stages but now question some aspects of the proposals, including concerns around the change in housing mix proposed, which seems to be moving away from smaller, affordable, properties. Given the importance of this development to the town the Town Development & Planning Committee asked the Town Council to consider whether the services of planning consults should be sought to advise on the implications of the amendments proposed in this application.

There followed some discussion on the application, after which it was **RESOLVED** that planning application 20/00596/FUL be supported in principle and, subject to cost, the advice of planning consultants be obtained in respect of 20/00607/VCN.

**Planning Authority Decisions:** Councillors considered the up-to-date position on decisions of the planning authority (Lancaster City Council) on planning applications previously deliberated. After some comments it was **RESOLVED** that the latest position on planning authority decisions be noted.

**Town Development & Planning Committee**: Councillor Watkins reported on the recommendations and actions arising from the meeting of the Committee on 6<sup>th</sup> July 2020 including:

- 1) Recommendation the Town Council seeks the advice of a planning consultant regarding planning application 20/00607/VCN prior to comments/objection are submitted to the planning authority;
- 2) Possible funding opportunities, although it was noted that the West Coast Railway does not qualify for a Heritage Building fund;
- 3) Arrangements for a VE & VJ Day Service;
- 4) Suggestion that a Transport Heritage Festival be held in the town;
- 5) Improvements to community noticeboards
- 6) Lancaster City Council's proposals for a 'District Recovery Project' to include'...recommended wayfinding signage and key messaging' to be installed in and around Market Street'

After some comments and questions, it was **RESOLVED** that the report of the Town Development & Planning Committee be noted, and recommendations approved.

**20066** Finance & Governance Committee: Councillor Grisenthwaite reported on the recommendations and actions arising from the meeting of the Committee on 8<sup>th</sup> July 2020 including:

- 1) Report on early discussions with a representative from Crag Bank Village Hall;

- 4) Quotation for planning consultant's advice as recommended by the Town Development and Planning Committee further quote(s) to be sought;
- 5) Findings and conclusions of the Internal Auditor's report;
- 6) Payments list for recommendation for approval to the Town Council
- 7) Debts outstanding as at 31<sup>st</sup> March 2020 and arrangements to review and improve the debt management and recovery procedures
- 8) Update and actions required relating to the installation of two bus shelters and improvements to Footpath No. 8

After some comments and questions, it was **RESOLVED** that the report of the Finance & Governance Committee be noted and recommendations approved by the Town Council, including the payments schedule.
