A Bridge too Far?

As part of a major bridge repair and refurbishment programme, Lancashire County Council has been successful in obtaining over £9 million of funding from the Department of Transport to upgrade the bridges on and over the A601(M) in Carnforth. Well, that's most bridges but not all of them and that's a cause of concern for many residents in the north of Carnforth.

The A601(M) is the dual carriageway that links Junction 35 on the M6 to the A6 at Pine Lake. The road was built in the 1960s as part of the then Lancaster Bypass and for some years, until the M6 was extended into Cumbria, it marked the northerly end of the motorway.

There are several bridges along this 1.3 mile stretch of road all of which are 60 years old and in need of refurbishment. As our local highway authority, Lancashire County Council is seeking to have the road de-classified as a motorway (the reason for the M in A601(M)) to become an "ordinary" dual carriageway but until recently it lacked the necessary funding to carry out the bridge upgrading.

The money provided by the Department of Transport will now enable this major programme of work to take place but oddly the County Council is not intending to repair one of the bridges; in fact, it intends to remove it completely and replace it with a junction on the dual carriageway. The bridge in question is North Road bridge that currently carries North Road from Netherbeck over the A601(M) towards Borwick.

One reason being given for the removal of the bridge is that the cost of replacing it with a new bridge, said to be £1.5M, is uneconomic and the cheaper alternative is to remove it and replace it with an "at grade" junction. This would probably involve installing traffic lights or building a new roundabout on the dual carriageway. It's open to question if this proposal would deliver a cheaper option than replacing the bridge with a new structure but we should consider other aspects of this proposal before concentrating solely on cost.

If the whole of the A601(M) is declassified it will cease to be considered a motorway and all road users would technically have access to it, including cyclists, increasing road safety issues. The building of a new junction at the point where North Road currently crosses the dual carriageway would technically allow traffic coming from the motorway direct access to North Road, increasing the likelihood of creating a new rat run into and out of Carnforth.

As the residents along North Road and on the Whelmar estate already know, traffic flows along North Road up and down Carnforth Brow to its junction with Kellet Road are already a cause for concern and the imposition of a 20mph speed limit for most of the length of the road has done little to allay those concerns.

To be fair, the County Council has said that it will aim not to increase the volume of traffic using North Road if the bridge is removed. However, unless access from the dual carriageway is restricted by creating a one-way only system from North Road, it's difficult to see how this aim could be achieved.

Perhaps a consideration that should be of equal concern to all of the residents of Carnforth in the event that a junction is installed is what might happen to the land to the north of the A601(M), along the stretch of North Road running towards Borwick. This is currently part of the green belt but if ready access is provided not only to the dual carriageway but directly to the M6, how long will it be before we see pressure building on Lancaster City Council (the planning authority) to open up this land for industrial development? The County Council is not hiding the fact that one of the alleged "benefits" of this proposal would be to open up land on either side of the dual carriageway for development.

Should this bother us or should we welcome new development in Carnforth even if it is at the very edge of the town and in the green belt? Carnforth Town Council wholeheartedly supports inward investment and the economic development of our town but not at any cost. We have several brown field sites closer to the centre of the community that could and should be developed first.

Whether you favour the creation of a new junction on the A601(M) or not, Lancashire County Council has promised to undertake a period of public consultation on its proposals so that you can have your say. The consultation is likely to start within the next two months and we will provide more details when they become available on our website and social media pages.

Care in the Community: Integrated Care Community (ICC) which includes third sector groups, local councils and GPs, has rallied to help support some of the most vulnerable people in Carnforth and neighbouring villages during the coronavirus (COVID-19) pandemic.

During the height of the pandemic, residents Liam Law and Andrea Wren set up the 'Carnforth and surrounding areas COVID-19 isolation support group' on Facebook and along with the support of Carnforth Town Council, Carnforth Free Methodist and a group of volunteers, have supported residents by doing their shopping, collecting prescriptions, walking their dogs and offering advice and support.

The volunteers have also referred people most in need to the Salvation Army. The charity has recorded more than 500 records of assistance including helping people with foodbank parcels in conjunction with Morecambe Bay Foodbank.

The Salvation Army has assisted people who are homeless or rehoused and families trapped by self-isolation. Volunteers at the charity have driven people to various hospital and GP appointments in conjunction with the support group.

Volunteer Liam Law said: "We started the group to help those most in need during what has been such an uncertain time. By having the service, it has given everyone a sense of continuity and really built up trust in our community. We've had fantastic support from so many people including Gay Tonks, Salvation Army, Town Cllrs Malcolm Watkins and Liz Jones and Bob Bailey, Carnforth Town Clerk"

Volunteer Andrea Wren added: "We have helped people in Carnforth, Holme, Silverdale, Warton and Bolton Le Sands. Everyone we have met has been really lovely and very grateful - it's brought out the good in people."

Carnforth ICC has worked closely with partners such as Carnforth Town Council and Lancaster City Council wellbeing partnership and the rural communities' group to look at how it can support the community holistically. Monthly multidisciplinary team meetings have helped to identify those residents who may need more support such as those with dementia or mental health conditions. Lancaster Integrated Care Community has also produced a community support bulletin for Lancaster, Carnforth and Bay ICCs which is updated and distributed to the community regularly and includes information about foodbanks, third sector organisations and community support.



GP leads have refocused their ICC management time to care for patients. Link Workers for Carnforth and Milnthorpe Primary Care Network have been instrumental in securing transport for patients to Park View surgery in Milnthorpe for routine appointments and to Ash Tree Surgery in Bolton-Le-Sands for weekly blood tests.

Emma Paul, Carnforth ICC Development Lead, said: "Between May-August, Jayne Crowther, Carnforth ICC Care Coordinator, has made 160 referrals/signposts for people living in the local communities to services such as Age UK Lancashire, Citizen's Advice, Fire Service for Home Fire Safety checks, Carer's Support and Community Therapy.

Carnforth ICC has also reinstated the monthly steering group meetings which bring together a wide range of health and social care representatives, town and city council and a wide range of community and voluntary groups and organisations. These meetings allow all attendees to give a brief update and reduce reduplication in offers of support and identify innovative ways of working and building solid partnerships between organisations to ensure that our local communities receive the best joined-up care."

Local businesses - New Covid19 control measures: You will be aware of the recent growth in confirmed Covid19 cases nationally and locally. The Government has responded by introducing new control measures for businesses. Let's stop the spread of Coronavirus: From 24th September any business or local authority that has a physical location and is open to the public, must display an NHS QR Code at the entrance. Grants available to support local charities and community groups:

Local charities and community groups can now apply for funds to help them support communities living in the Lancaster district.

Lancaster City Council and Lancaster District CVS are inviting local charities and community groups needing help to deliver projects and activities which will benefit local people to apply for funding from the Lancaster Community Fund.

The fund is made up of several charity funds donated to Lancaster City Council to support those living in disadvantaged areas of the community. Organisations can apply for grants of up to £1,000 and applications from new start up groups and small grassroots groups are particularly welcomed.

Examples of projects that the Lancaster Community Fund is looking to support include:

- > Activities for young people and equipment;
- > Improvements to outdoor public spaces such as community clean ups;
- > Training for volunteers;
- Community sports activities;
- Projects to reduce social isolation for vulnerable groups;
- Social enterprise activities;
- Money advice projects

Applications will be assessed on a quarterly basis by a panel consisting of city council, health and voluntary sector representatives, and two elected members of Lancaster City Council.

Consultation launches on Local Plan climate change measures



Lancaster City Council has launched the first stage of a review into the measures contained in its new Local Plan to tackle climate change.

An eight-week 'scoping' consultation has been launched to give people the opportunity to have their say on which policies of the plan they think should be revised to make sure it effectively addresses the council's declaration of a climate emergency.

The Local Plan's policies are important factors in making sure development takes account of climate change concerns as the policies are used in making decisions on all planning applications.

The intention is not to conduct a full review of the just completed Local Plan but to have a further look at its policies to see if they can be improved to achieve more on climate change mitigation and adaptation.

The declaration of a climate emergency commits the council to several actions, many of which are already underway.

These include the convening of a People's Jury to help identify how the council's own activities might be made net-zero carbon by 2030, installation of electric vehicle charging points in its car parks, and purchase of new vehicles and technology to reduce carbon emissions.
