- **1. Apologies –** Cllr Roly Parker (Problems with I.T)
- 2. **Declarations of Interest –** Normal declarations made by Cllr Watkins, Smith and Gristenthwaite
- 3. Minutes of the meeting held on 6th July (to follow) Accepted
- **4. Planning Applications -** Cllr Chris Smith updated on two applications Crag Bank and Haws Hill Recommendations on these -No objections
- 5. Events, including Remembrance Sunday and Transport Heritage Event. In regard to Remembrance Sunday it was decided that these plans should go ahead for an outdoor event, with a decision to be made on the Civic Hall event to be made at a later stage. Cllr Watkins to commence planning the service. Cllr Bromilow to work with Bob Bailey (clerk) to draft a letter and send out to external organisations and groups. Standards agreed Cllr Branyon to organize. Agreed that a mention of VE and VJ Days to be mentioned within the service.
- 6. Civic Hall Discussion in regards the opening of the Civic Hall, agreed that before this could be done a full risk assessment needs to be in place, Cllrs Branyon and Cllr Watson to meet at the civic hall and undertake a full risk assessment
- 7. Walking/Cycling Routes- Production of a map. Cllr Gristenthwaite gave an update on the production of a World War 2 Map, similar to the Remembrance Map. Cllr Gristenthwaite to take this proposal to full council
- 8. **Heritage Building Fund** -Cllr Roly Parker It is believed that funding such as this would not be available for the Railway cooling Towers and we would need to start looking at other possible funding available in order to try to keep this important landmark in Carnforth
